veterinary fees. If a natural breeding cannot be accomplished, and the bitch owner desires to proceed with an AI breeding, the bitch owner agrees to provide a credit card number to the collecting veterinarian to cover all AI costs, and to pay any travel

A. <u>Natural breeding</u>. The stud fee is \$2,200. OR the pick of the litter, at the stud owner's option. This fee is for a one-tie natural breeding. A payment of 20% of the fee (the "breeding fee") will be paid at the time of the breeding. The breeding fee is non-refundable, except in the event the stud owner selects the "pick of the litter" option.

The bitch owner agrees to have a back-up stud dog available in the event that the stud dog is servicing another bitch, or if the stud dog owner is unavailable, during the breeding window.

If the bitch does not conceive on the first service, one additional service will be provided within the next 18 months, at the bitch owner's option. In such event, the charge for the additional service shall be the then-existing stud fee, less the 20% non-refundable breeding fee previously paid.

B. <u>Fresh chilled</u>. The stud fee is \$2,200. A payment of 20% of the fee (the "breeding fee") must be received by the stud owner prior to the shipment of fresh chilled semen, and is non-refundable.

The bitch owner will pay all travel expenses of the stud owner, as well as veterinary expenses and shipping, all of which shall be promptly paid as a condition of this agreement. The bitch owner agrees to provide a credit card number to the collecting veterinarian to cover any costs. If the bitch does not conceive, no refunds will be made.

The stud fee is \$2,000. A payment of 50% of the fee (the "breeding fee") must be received by the stud owner prior to the release of semen from the bank, and is non-refundable. The bitch owner assumes all risks whatsoever as to the semen, at the time the semen is released from the bank. All costs of shipping and handling will be paid directly to the semen bank by the bitch owner, who shall also promptly pay all AI veterinary expenses, as conditions of this agreement. If the bitch does not conceive, no refunds will be made.

- 5. As to all breeding methods described in Par. 4, the remainder of the stud fee is due within two (2) weeks after the whelping of a litter of at least three live puppies. If fewer than three live puppies are whelped, the stud fee will be adjusted to an amount equal to 20% of the applicable stud fee per live puppy. The stud owner will sign the litter registration after receipt of full payment.
- 6. The bitch owner agrees that no puppy produced as a result of this breeding will be sold to a pet shop, agent or broker.
- 7. The stud owner is not obligated to sign an application for litter registration with the AKC, nor may such application be made, unless and until all applicable terms and conditions of this agreement have been complied with in full.
- 8. If the bitch's owner(s) fails to fulfill the conditions of this agreement, the bitch's owner(s) will be responsible for all reasonable attorney's fees, costs and/or expenses incurred by the stud owner to ensure compliance with the agreement.
